Sue Arnold – NNDC reported that Council tax for NNDC, band D has risen by just under £5 pa. NCC and Police have also applied an increase in total bill. Lawn Tennis Association has withdrawn its expected funding for the upgrading of the tennis courts and hub in Cromer. This was hugely disappointing but it is hoped that the necessary funding will be found from reserves. The market towns initiative has been successful with North Walsham using the NNDC funds to jump start projects. The Sporting Centre of Excellence based at Gresham's school has been a huge success with almost 100 young people being selected to take advantage of the coaching available. Plans for the Deep history project are well advanced and a launch date for the Trial expected very soon. There is no further news regarding the land off Long Lane. The new Local Plan is well advanced and the first consultation dates have been circulated. At this stage only larger allocation sites for towns are involved. The NNDC design guide is now available on line and makes fascinating reading. Interactive and very informative.

There was a short question and answer session on the Deep History project which it was hoped would make another tourist attraction and which follows the coastal path along with the chalk bed at Cromer.

Tim Adams - NCC updated members on the issues at Wellspring Road informing that due to undermining it had been closed and the holes were being monitored. The white line markings requested in the village had been completed. Tim had spent time out with both the ambulance service and Police. Norfolk Police had just placed 19 new officers in North Norfolk. ANPR's are being installed at strategic locations in the County.

Resolved to close the meeting to the public.
