1. To consider apologies for absence

2. To receive declarations of interest and Pecuniary interest authority None were declared.

3. To approve Minutes

Ordinary Parish Council Meeting Wednesday 20th July 2016 Resolved that these be approved.

4. Resolution to adjourn the meeting for public participation, Police and District and County Councillor Reports (15 minutes maximum)
Resolved to open the meeting to the public.

Hilary Cox - informed that the NDR was progressing well and a main gas pipe had to be diverted. The footpath survey programme was still open for another 9 years. Libraries are now issuing a regular electronic newsletter and an "app" was available for smart phones. A new bus timetable had been launched. The Boundary review was still underway and this would reduce the number of councillors from 44 to 40. The Norfolk and Suffolk devolution consultation was concluded and the figures relating to this were read out. Attendance of a Highways workshop was highlighted together with all the relevant Highways responsibilities. The NNDC Greenbuild event is on soon.

PCSO De Fathalla outlined that there had been 1 crime reported and that it was domestic. Discussion took place in relation to the speeding of emergency vehicles and that if they are on "blues" then, the drivers can proceed at any speed. **Resolved to close the meeting to the public.**

There had been 3,371 visits and the site was being updated regularly. The Football Club were working on a document for the website and would supply this shortly. All new items will be welcomed.

- 5.3 Tubs at The Green, Long Lane volunteer required. Letter sent to MIG Anglia no response received. However a volunteer may have been sourced. The Clerk was asked to write a letter to acknowledge and accept the kind offer.
 - One of the tubs needed attention the Clerk would investigate.
- **5.4 SCT container Big Society Fund application -** funding received and items being purchased.

- 5.5 SCT update from working group and Clerk re registration of land Lesley Sparrow, Vic Purdy along with John Houlgate had attended a meeting at Norfolk Wildlife Trust. NWT would be assessing the option of transferring the area to them in late September. If this progresses there will be consultations held with the public and the SCT volunteers. The Clerk was trying to resolve the issue of the deeds and the registration of the area with the land registry. A meeting had been held with Hansells in order to progress this matter.
- 5.6 Norse playing field update waiting for commencement date The Clerk had chased Norse again and they had a change of staff again. Advice had been received that this project should commence over the next few weeks.
